# NOTICE

NOTICE is hereby given that the Sixty-Ninth annual general meeting of the shareholders of the Company will be held on Saturday, August 29, 2009 at 10.00 a.m. at Taj Residency, 8-N-12, CIDCO, Dr. Rafiq Zakaria Marg, Rauza Bagh, Aurangabad 431 003, Maharashtra, to transact the following business:

#### **ORDINARY BUSINESS:**

- 1. To receive, consider and adopt the audited balance sheet as at March 31, 2009 and the profit and loss account for the year ended on that date and the reports of the directors and the auditors thereon.
- 2. To declare dividend, if any, for the year 2008-2009.
- 3. To appoint a director in place of Mr. Ashok A. Chandavarkar, who retires by rotation and being eligible offers himself for reappointment.
- 4. To appoint a director in place of Mr. Girish C. Sharedalal, who retires by rotation and being eligible offers himself for reappointment.

## SPECIAL BUSINESS:

- 5. To consider and, if thought fit, to pass, with or without modifications, the following resolution as a special resolution:
  - "RESOLVED THAT pursuant to section 224 and other applicable provisions if any, of the Companies Act, 1956, and subject to the approval of the members of the Company at the ensuing annual general meeting, M/s. S.R. Batliboi & Associates, Chartered Accountants, be appointed as the statutory auditors of the Company in place of M/s. S.R. Batliboi & Company, the retiring auditors, to hold office from the close of the ensuing annual general meeting till the conclusion of the next annual general meeting on such terms, conditions and remuneration as may be mutually agreed between the board of directors and the said auditors.
  - **RESOLVED FURTHER THAT** the board of directors be and is hereby authorised to do all such acts, deeds, matters and things as may be necessary to implement this resolution."

  - "RESOLVED THAT pursuant to the provisions of schedule XIII and sections 198, 269, 309, 310, 311, 341 and other applicable provisions, if any, of the Companies Act, 1956, approval of the shareholders be and is hereby accorded to the appointment of Mr. Mohan A. Chandavarkar as the Managing Director of the Company for a period of five years w.e.f. April 01, 2009 on the following terms and conditions, remuneration and perquisites, upto a maximum as may be permitted under schedule XIII of the Companies Act, 1956, or any modification or re-enactment thereof as in force for the period covered under the agreement entered into by the Company with Mr. Mohan A. Chandavarkar or on the basis of such other law or notification as may be permissible or applicable:

#### REMUNERATION

- a) Salary: The salary of the said Mr. Chandavarkar shall be Rs. 173,000/- p.m. commencing from April 01, 2009 with annual increment of Rs.10,000/- p.m. rising upto Rs. 213,000/- p.m. in the maximum.
- **Commission:** In addition to salary and perquisites, commission not exceeding 0.50 percent of the net profits of the Company in a financial year, computed in the manner laid down in section 309(5) of the Companies Act, 1956 and subject to the overall ceilings laid down under sections 198 and 309 of the Companies Act, 1956.
- c) **Perquisites:** Perquisites referred to in Category 'A', 'B' and 'C' below:

#### **CATEGORY 'A':**

- a) Accommodation: Expenditure on hiring unfurnished accommodation for himself, shall be subject to a ceiling of 60% of his salary over and above 10% payable by himself. However, if the Company does not provide him residential accommodation, the director is entitled to house rent allowance of 60% of his salary. Where the accommodation in a Company owned house is provided, the director will pay to the Company 10% of his salary. The expenditure incurred by the Company on gas, electricity, water and furnishings to be evaluated as per the Income Tax Rules 1962, subject to a ceiling of 10% of his salary.
- **b) Medical Benefits:** Medical expenses incurred for self and family, subject to a ceiling of one month's salary in a year or three month's salary in a block period of three years.
- c) Leave Travel Concession: Once in a year, for self and family as per rules applicable to other managers of the Company.
- **d) Club Fees :** Reimbursement of club fees, subject to a maximum of two clubs, excluding life membership and admission fees.
- e) Personal Accident Insurance: Restricted to a premium not exceeding Rs.4,000/- p. a.
- **f) Health Mediclaim Insurance :** The health mediclaim insurance shall be payable to the said Mr. Chandavarkar as per the rules of the Company.

## CATEGORY 'B':

- a) Contribution to Provident Fund: The Company shall pay an amount to the provident fund as applicable to the senior officers of the Company, but not exceeding 12% of the salary or such other limits prescribed by the Government.
- **b) Contribution towards Superannuation Fund :** The Company's contribution towards superannuation fund shall be an amount equivalent to 15% of the salary, applicable to the other senior officers of the Company.
- c) Contribution to Provident Fund and Superannuation Fund: Contribution to provident fund and superannuation fund will not be included in the computation of the ceiling on perquisites to the extent these either singly or put together, are not taxable under the Income Tax Act.
- **d) Gratuity:** Gratuity payable shall not exceed half month's salary for each completed year of service, subject to ceiling as per the Payment of Gratuity Act, 1972.
- e) Leave Encashment: Encashment of leave at the end of the tenure will not be included in the computation of the ceiling on perquisites.
- f) Bonus and other benefits in accordance with the Company's rules and regulations in force from time to time.

## **CATEGORY 'C':**

a) Car and Telephone: Provision of car for use on Company's business and telephone at residence will not be considered as perquisites. Personal long distance calls and use of car for private purpose shall be billed by the Company to the said Mr. Chandavarkar.

- b) Earned / Privilege leave: The said Mr. Chandavarkar shall be entitled to earned / privilege leave on full pay and allowances as per Company's rules but not more than one month's leave for every eleven month's of service. Leave accumulated will be allowed to be encashed on retirement / resignation / death, subject to a ceiling of eight month's salary or as permitted under the Income Tax Laws applicable at that time, whichever is lower.
- c) Reimbursement of Entertainment expenses: The said Chandavarkar shall be entitled to reimbursement of expenses actually and properly incurred for the business of the Company as well as other expenses incurred by him in the performance of duties on behalf of the Company.

**RESOLVED FURTHER THAT** where in any financial year, during the currency of tenure of the whole-time director, the Company has no profits or its profits are inadequate, the Company shall pay him remuneration by way of salary and perquisites not exceeding the limits as prescribed under schedule XIII of the Companies Act, 1956, or any modification or re-enactment thereof.

**RESOLVED FURTHER THAT** the board of directors of the Company be and is hereby empowered to modify the terms and conditions of the appointment of the said Mr. Mohan A. Chandavarkar, subject to the conditions that such modification complies with relevant sections of the Companies Act, 1956, and schedule XIII of the Companies Act, 1956.

Chandavarkar as the Joint Managing Director of the Company for a period of five years w.e.f. March 01, 2009 on the following terms and conditions, remuneration and perquisites, upto a maximum as may be permitted under schedule XIII of the Companies Act, 1956, or any modification or re-enactment thereof as in force for the period covered under the agreement entered into by the Company with Mr. Nandan M. Chandavarkar or on the basis of such other law notification as may be permissible or applicable:

## **REMUNERATION**

- a) Salary: The salary of the said Mr. Chandavarkar shall be as under:
  - ◆From March 01, 2009 to March 31, 2009 Rs.131,000/- p.m.
